#### B. Adoption of the Agenda

#### D. CEO Report

Bill Carpenter, Chief Executive Officer, presented the CEO Report which included presentations from Mike Burns, Director of Accounting Services on the TOPS Report and Net Promoter Score (NPS) and Julie Boasi, Director of Service Planning on the Bike Share Program (The power point presentations are attached to these Minutes).

#### Questions/Comments on the TOPS Report & NPS:

- Commissioner Jankowski asked with the detractors and promotors do we know the frequency at which they ride. Mike Burns, Director of Accounting Services stated that he does not have that information off the top of his head but that we do have it and he would be happy to share that after the meeting.
- Commissioner McDonald asked when we will start adding back in the frequent service. Mike Burns, Director of Accounting Services stated that Julie Boasi will be sharing that information in her presentation.
- Commissioner Ansbrow wanted to just remind the public that we came to the aid of the City School District and unfortunately that required us to remove our frequent route

- service and that they will need to be patient with us until we can get those routes reintroduced into the system.
- Commissioner Kosmerl asked if we survey students when we are conducting the customer survey. Bill Carpenter, CEO stated that we are looking for choice riders that are 18 and older. The City School District is contracted work, so we do not survey students.

#### Questions/Comments on the Bike Share Program:

- Commissioner Bensley asked if the season is only those five months that were listed on the slide. Julie Boasi, Director of Service Planning stated correct the season is from May 1<sup>st</sup>- November 1<sup>st</sup>.
- Commissioner Kosmerl asked if the 31,000 rides was just RTS bikes. Julie Boasi, Director of Service Planning stated that number was system wide.
- Commissioner McDonald stated that there is a livability community initiative for older adults and having access to other modes of transportation. Have we ever considered getting tricycles? Julie Boasi, Director of Service Planning stated that she can talk with HOPR and see if that is an option for next season.
- Commissioner Jankowski asked if HOPR is a privately owned company and how are they making money? Julie Boasi, Director of Service Planning responded yes, they are a private company and right now they are being subsidized by the Congestion Mitigation and Air Quality Improvement (CMAQ) grant that RTS and the City received. HOPR is using this time to develop relationships for potential sponsorship opportunities. Commissioner Jankowski then asked about vehicle loss. Julie stated that each vehicle has a GPS unit in the main part of the vehicle, and it cannot be removed without making the vehicle inoperable. HOPR knows the vehicles location and continues efforts to retain all vehicles.
- Commissioner Ansbrow asked if we have thought about offering this to our Access customers as well. Not sure what those vehicles would look like, but I think this is something we should look into for them. Julie Boasi, Director of Service Planning stated that she can certainly talk to HOPR about that and see what might be available to offer that population.

#### *Questions/Comments on the Miscellaneous:*

• Commissioner Kosmerl asked what time period does the 192,000 Veteran's pass rides cover. Bill Carpenter, CEO stated that is since the program started in July of 2020 so, about 15 months' worth of information.

On motion of Commissioner Ansbrow, seconded by Commissioner Bensley, the CEO Report was accepted by unanimous vote.

#### E. Financial Report

Scott Adair, Chief Financial Officer, presented the financial report, a copy of which is attached to these Minutes.

On motion of Commissioner Kosmerl, seconded by Commissioner Ansbrow, the Financial Report was accepted by unanimous vote.

• Commissioner Jankowski asked how this project is being funded. Scott Adair, CFO stated that it is being funded through our normal capital project funding of 80% federal and 10% state and local. This mix could change if we are successful in receiving any earmark grants, but the max for us would be 10%. Commissioner Jankowski then asked if the GTC on-route charging resolution was related to this project. Dave Belaskas, Director of Engineering & Facilities Management stated that it is unrelated in the sense that it is on-route, but it is for our buses. The on-route charging would be an enhancement to our ability to charge our electric fleet.

Resolution RGRTA 43-2021 was moved on motion of Commissioner McDonald, seconded by Commissioner Ansbrow, the aforementioned Resolution, a copy of which is attached to these minutes, was unanimously approved.

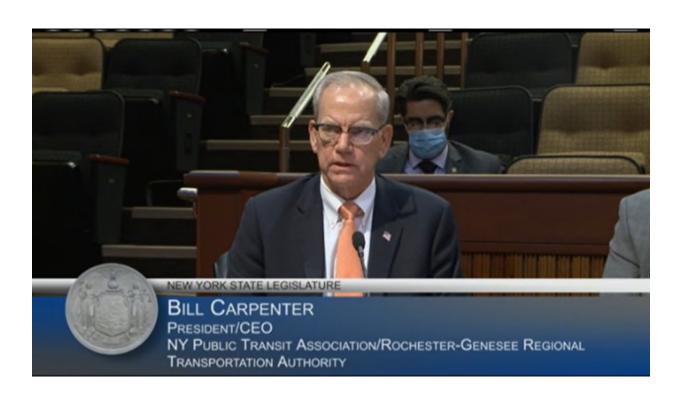

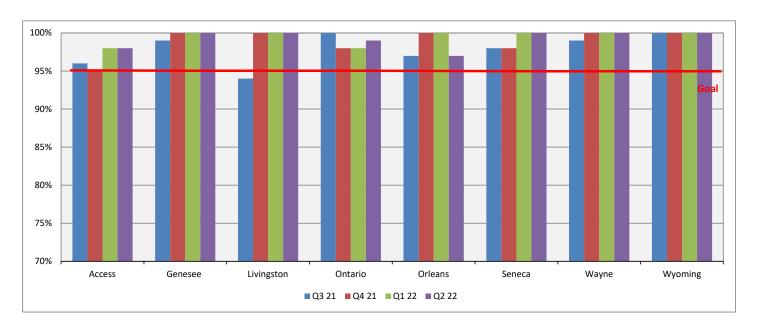

### Customer Satisfaction: Trends by Quarter

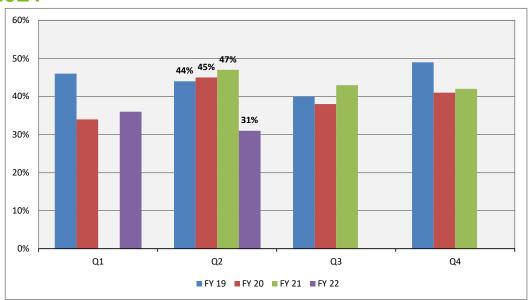
 Customer Satisfaction at Access and the Regionals exceeded goal at all locations

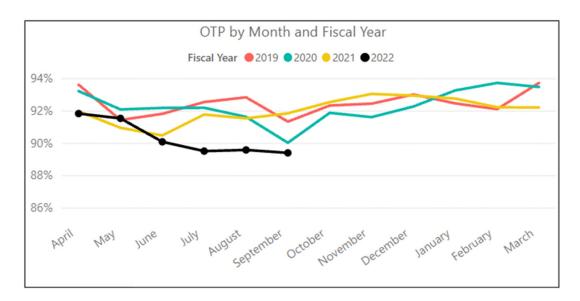

### **OTP-RTS Monroe: Performance Trends**

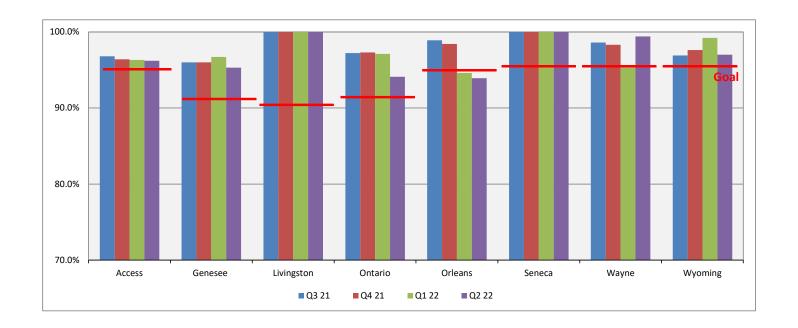
- Within Q2, monthly OTP ranged from 89.4% to 89.6% vs. a goal of 85.0% (measured, not scored for Q2 TOPS)

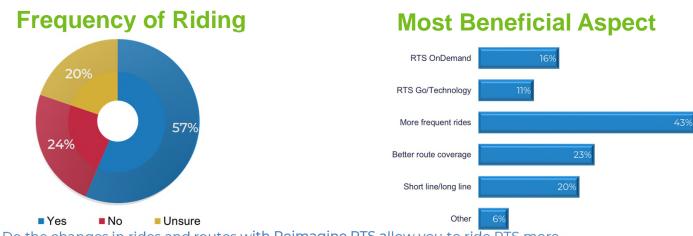

### NPS: Reimagine RTS

- The changes made with Reimagine allowed over half (57%) of customers to ride more frequently, up 3% from the prior wave.
- More frequent rides and better route coverage remained the two most beneficial things from Reimagine.



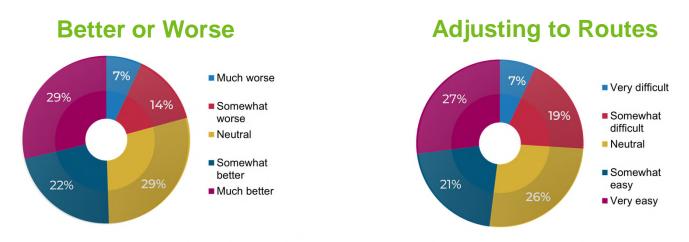
Q16 – Do the changes in rides and routes with Reimagine RTS allow you to ride RTS more frequently?

### **NPS:** Reimagine RTS

• The majority of customers continued to feel that the changes were better and that adjusting to routes was easy.



Q16 – Are the changes with Reimagine RTS (ride frequency, personalized rides, route coverage) better, or worse?

## NPS: Reimagine RTS-Customer Insights

- Promoters felt that the changes with Reimagine allowed for more convenient times and were just overall better
  - "Because the new system helps me to get around better."
  - "The new system has some quirks to work out but, overall, not bad."
- Passives had fewer negative comments about Reimagine, down 10% from Wave 43.
  - "The new bus system is harder, but at the same time, you still get to where you need to go."
  - "So far, happy with the increased frequency."



## NPS: Reimagine RTS-Customer Insights

- Detractors were the most likely to make comments regarding Reimagine, though they made fewer negative comments compared to Wave 43.
  - "Because I now have to walk from the mall to my job (a 20-minute walk) because a bus no longer goes down there."
  - "You took away buses in certain areas that are desperately needed back."
  - "With the recent new "revamped system", I feel the service has become less passenger efficient."



## Summary

- Our Q2 TOPS score reflects achievement above goal for three of four key result areas with Net Promoter Score below goal and reflective of our customers continuing to adapt to the service changes brought about by Reimagine.
- Looking ahead to the second half of the year, our initial expectation was that the system would begin to stabilize and respond favorably to necessary adjustments.
- As the year progresses, we expect that the changes made to our service to meet the needs of RCSD, combined with any adjustments to restore our more frequent service, may continue to impact both Net Promoter Score and On-Time Performance.

## Becoming a Leader in Mobility

- Our Governance Retreats in 2014, 2015 and 2016 laid the foundation for our system today. Initial guidance was to support mobility initiatives in the region, while prioritizing improved transit service.
- For the past 5 years, we partnered with the City of Rochester on Bikeshare and Vanpool offerings, while completing the Regional Redesign and launching Reimagine RTS.
- Now using our own grant funding we are offering Bikeshare and Vanpool services coordinated with our municipal partners.









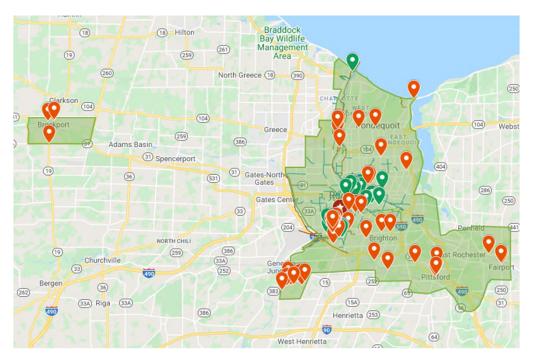

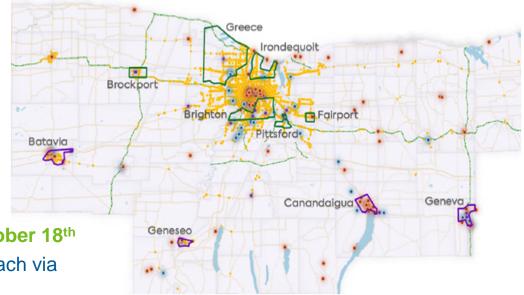

### Coordination with the City of Rochester

#### Behind the Scenes

- City of Rochester and RTS have separate contracts with HOPR
- Each Town, City, Village, College, etc. has their own permits, contracts, and arrangements for how the bike share will operate within their area

#### Public-Facing

- RTS / City / HOPR have all worked together to launch a cohesive bike share system
- Bikes and scooters can move between stations in the City and stations in the suburbs







### **Vehicles**

- Pedal bikes and pedal-assist electric bikes (e-bikes) are available systemwide
- E-scooters are available in the City of Rochester

### **Stations**

- 63 total stations
  - 35 with metal racks, 28 with sidewalk decals
- Accommodate both bikes and scooters
- Stations are modular and hold 6-12 vehicles per location
- Trips must begin and end at stations

## **Statistics**

- There were a total of approximately 31,000 trips by more than 7,000 unique customers over the 2021 season
- For the whole 2021 season the system averaged 151 weekday trips and 68 weekend trips
- At its highest point, the system averaged 226 weekday trips and 95 weekend trips

- Phase II will build on this success and expand the bike share system in 2022 and beyond

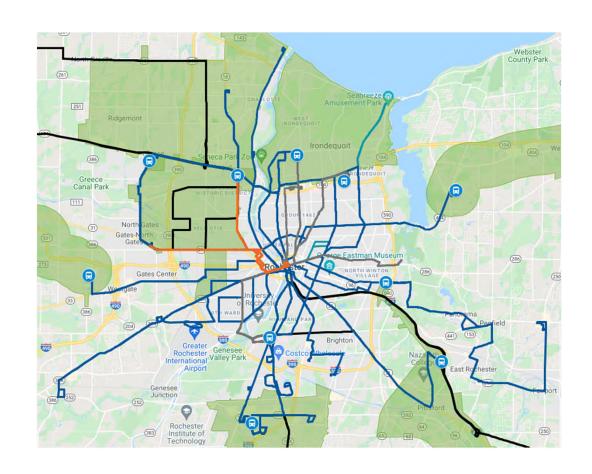

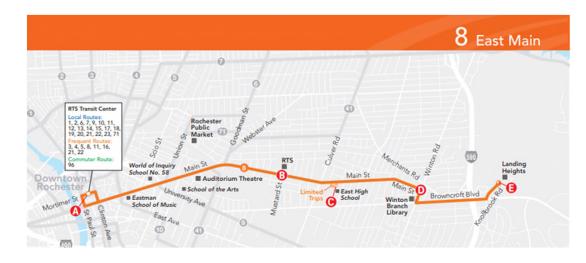

# RESOLUTION ESTABLISHING THE AUTHORITY AS LEAD AGENCY AND ADOPTING A NEGATIVE DECLARATION PURSUANT TO THE NEW YORK STATE ENVIRONEMNTAL QUALITY REVIEW ACT FOR THE RTS SENECA BUS FACILITY PROJECT

WHEREAS, the Rochester Genesee Regional Transportation Authority (the "Authority") proposed to undertake a project to construct a new bus facility in Seneca County by undertaking the RTS Seneca Bus Facility Project (the "Project"); and

WHEREAS, the Project involves the purchase of a 1.8-acre site at the intersection of Thurber Drive and DiPronio Drive in the Village of Waterloo, Seneca County, NY from Seneca County, the construction of a new approximately 13,600 square foot bus facility that would provide space for sheltered bus storage, minimal maintenance activities, bus washing and administrative office space, additional site improvements including a parking area, sidewalks, lighting, landscaping, utilities, stormwater management and sanitary sewage connection; and

WHEREAS, pursuant to Article 8 of the Environmental Conservation Law, as amended, the New York State Environmental Quality Review Act ("SEQRA") and the regulations adopted pursuant thereto by the New York State Department of Environmental Conservation ("NYSDEC"), being 6 NYCRR Part 617, as amended (the "Regulations"), the Authority desires to comply with SEQRA and the Regulations with respect to the Project; and

WHEREAS, the Authority with its staff and consultants (collectively referred to as the "Authority") has assisted the Federal Transit Administration ("FTA") with FTA's compliance with the National Environmental Policy Act of 1969 ("NEPA"), which also applies to the planning and development of the Project, by developing information and analyses necessary to complete a NEPA Environmental Assessment of the Project dated November 29, 2016 (hereinafter the "NEPA EA"); and

WHEREAS, the Authority has prepared and submitted the NEPA EA to FTA, which discusses and analyzes: (i) the purpose of the need for the Project; (ii) alternatives to the Project, (iii) each of the applicable potential impacts, including indirect and cumulative impacts, from the Project, including, but not limited to impacts to traffic and parking, community character, land use and zoning, energy use, waste disposal, socioeconomic factors, and archeological and historic resources; and (iv) such matters as are needed to assist FTA in satisfying its obligations under Section 106 of the National Historic Preservation Act, to satisfy the requirements of Section 4(f) of the U.S. Department of Transportation Act of 1966, and to satisfy the requirements of the New York State Historic Preservation Act of 1980; and

WHEREAS, FTA has indicated that the Project is eligible for categorical exclusion; and

WHEREAS, in accordance with the requirements of SEQRA, the Authority completed Part 1 of a Short Environmental Assessment Form ("EAF") for the Project, and provided a copy

of Part 1 of the EAF to all involved and interested agencies, as those terms are defined in the Regulations, with a request for concurrence for the Authority to designate itself as "lead agency," as this term is defined in the Regulations, for the purpose of undertaking a coordinated review of the Project, and;

WHEREAS, the Authority received no objections to it acting as lead agency from any of the involved or interested agencies and the 30-day period provided for any such objections has passed;

WHEREAS, the Authority has undertaken the required SEQRA review of the Project, including undertaking appropriate studies and analyses as more fully documented in the NEPA EA regarding potential impacts of the Project, and the Authority has also analyzed such impacts by causing the completion of the EAF, including Parts 1, 2 and 3 thereof (Parts 1 and 2 of the EAF are attached as Attachment A); and

WHEREAS, as required by SEQRA, including by 6 NYCRR. §617.15, the Authority has considered the NEPA EA, as well as the EAF, including Parts 1, 2 and 3 thereof; and

WHEREAS, the Authority has reviewed determinations and correspondence from the FTA concerning potential impacts from the Project; and

WHEREAS, pursuant to the Regulations, the Authority has considered the significance of the potential environmental impacts of the Project by (a) using the criteria specified in Section 617.7 of the Regulations, and (b) examining the EAF for the Project, together with other available supporting information, to identify the relevant areas of environmental concern, and (c) thoroughly analyzing the identified areas of relevant environmental concern;

WHEREAS, the Authority desires to (i) classify the Project under SEQRA, (ii) serve as lead agency for purposes of a coordinated review under SEQRA, and (iii) determine significance for the Project under SEQRA.

NOW, THEREFORE, BE IT RESOLVED, that:

- 1. The Authority designates itself lead agency pursuant to SEQRA and the Regulations for purposes of undertaking a coordinated review for this Project; and
- After considering the scope and components of the Project, and the Regulations set forth at 6 NYCRR Sections 617.4 and 617.5, the Authority classifies the Project as an "Unlisted" action under SEQRA; and
- 3. The Authority has determined that no significant adverse environmental impacts are noted in the EAF for the Project, and none are known to the Authority. Therefore, the Authority hereby determines that the Project will not have a significant adverse environmental impact, and the Authority will not require the preparation of an environmental impact statement with respect to the Project, and
- 4. The findings and conclusions contained in the Negative Declaration attached hereto as Attachment B are hereby adopted and incorporated by reference into this Resolution.

- 5. The Chief Executive Officer of the Authority and/or his designee are authorized and directed to cause this negative declaration resolution and the attached Negative Declaration to be executed and filed in accordance with the Regulations.
- 6. The Chief Executive Officer and/or his designee are hereby authorized, empowered and directed, for and on behalf of the Authority, to perform any and all actions and to execute any and all documents on behalf of the Authority as they may deem necessary, appropriate or advisable to carry out the intent and purposes of the foregoing resolutions.
- 7. This Resolution shall take effect immediately.

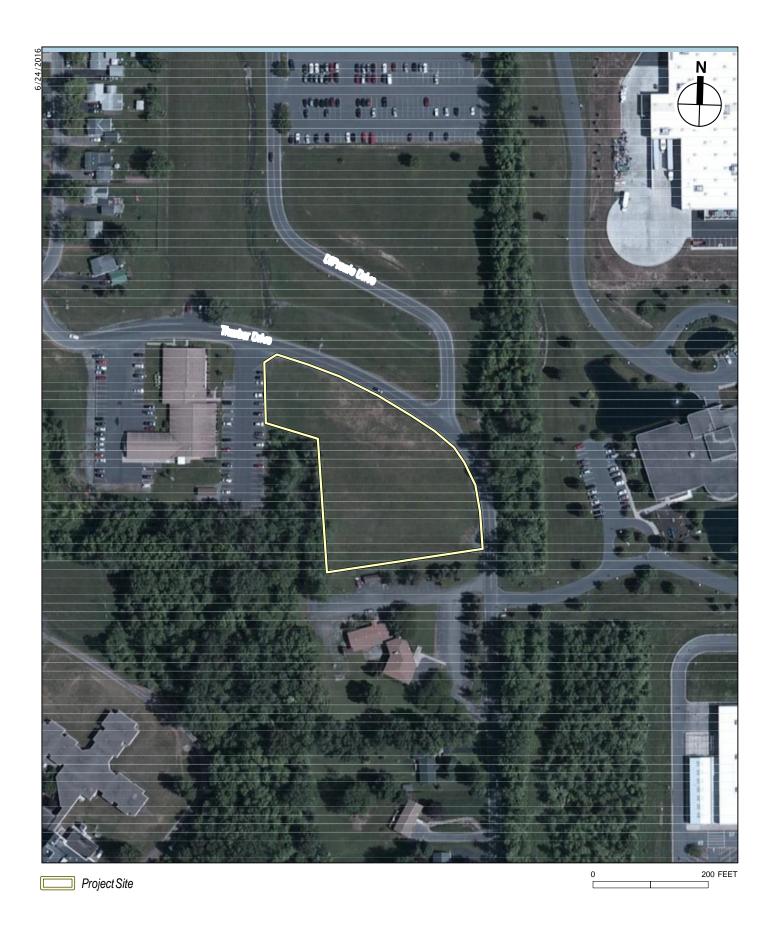

WHEREAS, GTCS, Inc. is a subsidiary of RGRTA, and serves as the fiscal agent for GTC; and

WHEREAS, pursuant to the Memorandum of Understanding between GTCS, Inc. and GTC dated April 30, 1999, GTC is authorized to accept, develop, and administer contracts for GTC work program related activities, provided the requirements in Section II (E) (3) of the Memorandum of Understanding are fulfilled.
